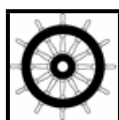

"Weber Marine Damping Floor"
composed of the following combination (from surface and upwards):

Layer 1: 1 mm - 2 mm thick Viscoelastic layer "Weber Marine VEM PU-1 (density 1.34 kg/m³),
Layer 2: 1 mm - 4 mm thick steel plate.

Total thickness of the product is max. 6 mm.

Application/Limitation

Primary deck covering, not generating excessive quantities of smoke nor toxic products in fire.

The product may be applied over any steel or non-combustible material.

Approved colour (tested colour): grey and brighter colours.

Maximum organic content: 11 %.

Not to be used as an integrated part of a horizontal class A division unless tested as such.

The product may also be used as floor covering in accordance with IMO 2010 FTP Code Part 5 appendix 4 paragraph 4.9.2.

Each product is to be supplied with its manual for installation and use.
