## Product description

“Weber Marine PU Flex Anti-slip Coating”

is a floor construction consisting from bottom to top of approx. 0.9 mm thick layer of “weberfloor 4771N PU Flex Coating” (density 1.6 kg/m<sup>3</sup>), a layer of “weberfloor Quartz Sand” (grain size 0.3 – 0.8 mm, density 2.65 kg/m<sup>3</sup>) and approx. 0.9 mm thick layer of “weberfloor 4772N PU Top Coat” (density 1.4 kg/m<sup>3</sup>).

The floor construction has nominal thickness of 2 – 3 mm and nominal density of approx. 2.0 g/cm<sup>3</sup>.

## Application/Limitation

Primary deck covering, not generating excessive quantities of smoke nor toxic products in fire.

The construction may be applied over any steel or non-combustible material.

### weberfloor 4771N PU Flex Coating:

Approved for all colour variations

Max. organic content: 50 %

### weberfloor 4772N PU Top Coat:

Approved for all colour variations.

Max. organic content: 66 %

Not to be used as an integrated part of a horizontal class A division unless tested as such.

The construction may also be used as floor covering in accordance with IMO 2010 FTP code Part 5 appendix 4 paragraph 4.9.2.

Each product is to be supplied with its manual for installation, use and maintenance.
